

BOARD OF DIRECTOR' DECISION

OIL TERMINAL S.A. Constanta's Board of Directors, gathered within the meeting of 23.02.2024,

As a result of the debates noted in the Minutes on report no. 159/22.02.2024, on behalf of the Development Director and of the Shareholding-Communication Office,

DECIDES:

Art. 1 The convocation and convener of the company's Shareholders Ordinary General Assembly, taking place on 28(29).03.2024, 11:00 h , with the following agenda, is endorsed:

1. Approval of the purchase by the company of legal services of consultancy, assistance and/or representation in the field of commercial law
2. The empowerment of the meeting' President to sign the decisions of the assembly.
